

**AFFIDAVIT OF COMPLIANCE FOR
MINORS AND THEIR PARENTS OR LEGAL GUARDIANS**

In accordance with the requirements of the Pennsylvania Child Protective Service Law
- 23 Pa. C.S. Section 6344

We, the parent or legal guardian of the minor applicant and the minor applicant, hereby swear or affirm that the minor is not disqualified from service under 23 Pa. C.S. Section 6344(c) or has not been adjudicated/convicted of an offense enumerated below the same of which is found in subsection (c) or a has not been adjudicated/convicted of an offense similar in nature to those crimes listed in subsection (c) under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth.

We, the parent or legal guardian of the minor applicant and the minor applicant, hereby swear or affirm that the minor has been a resident of Pennsylvania during the entirety of the previous ten-year period or We, understand that if the minor has not been a resident of Pennsylvania during the entirety of the pervious ten-year period, but has received certification from the FBI since establishing residency in Pennsylvania in the last 60 months we must provide a copy of the certification.

We, swear/affirm that, if providing certifications that have been obtained since establishing residency in Pennsylvania, the minor has not been disqualified from service as outlined below or has not been adjudicated/convicted of an offense similar in nature to a crime listed below under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puelto Rico or a foreign nation, or under a former law of this Commonwealth since obtaining such certification.

We, swear/affirm that the minor has not been named as a perpetrator or as the alleged perpetrator in a pending child abuse investigation or as the perpetrator of a founded report or an indicated report.

We, swear/affirm that the minor has not been adjudicated/convicted of any of the following crimes under Title 18 of the Pennsylvania consolidated statutes or of offenses similar in nature to those crimes under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth:

- Chapter 25 (relating to criminal homicide).
- Section 2702 (relating to aggravated assault).
- Section 2709.1 (relating to stalking).
- Section 2901 (relating to kidnapping).
- Section 2902 (relating to unlawful restraint).
- Section 3121 (relating to rape).
- Section 3122.1 (relating to statutory sexual assault).
- Section 3123 (relating to involuntary deviate sexual intercourse).
- Section 3124.1 (relating to sexual assault).
- Section 3125 (relating to aggravated indecent assault).
- Section 3126 (relating to indecent assault).
- Section 3127 (relating to indecent exposure).

Section 4302 (relating to incest).
Section 4303 (relating to concealing death of child).
Section 4304 (relating to endangering welfare of children).
Section 4305 (relating to dealing in infant children).
A felony offense under section 5902(b) (relating to prostitution and related offenses).
Section 5903(c) or (d) (relating to obscene and other sexual materials and performances).
Section 6301 (relating to corruption of minors).
Section 6312 (relating to sexual abuse of children).
The attempt, solicitation or conspiracy to commit any of the offenses set forth in this paragraph.

We, swear/affirm that the minor has not been adjudicated/convicted of a felony offense under Act 64-1972 (relating to the controlled substance, drug device and cosmetic act) committed within the past five years.

We, understand the minor shall not be approved for service if named as an alleged perpetrator or a perpetrator of a founded or indicated report of child abuse or have been convicted of any of the crimes listed above or of offenses similar in nature to those crimes under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth.

We, understand that if the minor is arrested for or adjudicated/convicted of an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law as listed above, or am named as an alleged perpetrator or a perpetrator of a founded or indicated report of child abuse, We must provide the administrator or designee with written notice not later than 72 hours after the arrest, conviction or notification that the minor has been listed as a perpetrator in the Statewide database.

We, understand that if the person responsible for employment decisions or the administrator of a program, activity or service has a reasonable belief that the minor was arrested or convicted for an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law, or was named as an alleged perpetrator or a perpetrator of a founded or indicated report of child abuse, or We, have provided notice as required under this section, the person responsible for employment decisions or administrator of a program, activity or service shall immediately require me to submit current certifications obtained through the Department of Human Services, the Pennsylvania State Police, and the Federal Bureau of Investigation, as appropriate. The cost of certifications shall be borne by the employing entity or program, activity or service.

We, understand that if the minor willfully fails to disclose information required above, We commit a misdemeanor of the third degree and shall be subject to discipline up to and including denial of a volunteer position.

We, understand that certifications obtained for the volunteering purposes can only be used for that purpose and cannot be used for employment purposes.

We, understand that the person responsible for employment decisions or the administrator of a program, activity or service is required to maintain a copy of my certifications.

We, hereby swear/affirm that the information as set forth above is true and correct. I understand that false swearing is a misdemeanor pursuant to Section 4903 of the Crimes Code.
